Store Cattle Sales will run under the following rules:-

Store cattle <u>ONLY</u>, viz. steers and heifers, feeding bulls and grazing cows can be sold **NO** BREEDING STOCK, STOCK BULLS, CALVES, EWES & LAMBS

- 1) The "DROP & GO" system will operate as for primestock.
 PLEASE ENSURE YOUR PASSPORTS AND DRAWING LIST ARE FULLY
 COMPLETED, SIGNED WITH ADDRESSES AND TELEPHONE
 NUMBERS. Any reserves should be clearly written next to Lots on the
 white form and given to market staff on arrival.
- 2) The yard will be open from 7.30am. Please take advantage of this fact to enable stock to be booked properly.
- 3) Glue will be available from the Knighton office in advance. Again, on farm ticketing helps everyone.
- 4) Once you have unloaded your stock, please move the empty vehicle straight away in order to avoid congestion.
- 5) Market staff will process the stock in the usual efficient manner.

BUYERS

- 1) Buyers must notify the office of their intention to come to market ONLY BONA FIDE BUYERS WILL BE ALLOWED IN THE MARKET giving excuses to see your stock sold <u>CANNOT</u> be entertained.
- 2) Social distancing (2 metres between each buyer) <u>MUST BE ADHERED</u> TO IN ALL AREAS.
- 3) Buyers will be allowed into the market office one at a time
- 4) Buyers **SHOULD** wear protective gloves and masks whilst in the market

- 1) If you show any symptoms of the virus DO NOT ATTEND!
- 2) We will continue our policy of telephoning for stock IF WE HAVE NOT TELEPHONED YOU AND YOU INTEND TO BRING STOCK PLEASE RING THE APPROPIATE MARKET WITH PROPOSED NUMBERS



COUNTRYSIDE STEWARDSHIP MID-TIER & CAPITAL WORKS AND HEDGEROW & BOUNDARIES GRANT SCHEME

The application window for the above schemes is now open in England. Details are as follows:

Mid-Tier

Mid-Tier Application Packs need to be ordered by <u>31st May 2020</u>. If you need a Catchment Sensitive Field Officer to approve capital works like a covered muck store or concreting, they also need to be booked by <u>31st May 2020</u>.

Applications then need to be submitted by 31st July 2020.

Capital items include:
Concreting of farmyards, with cross-drains
Livestock handling building
Manure stores
Yard drainage
Fencing
Sprayer wash down buildings
Slurry & silage store roofing

For capital items only you have two years to do the work. Capital only Mid-Tier Agreements are up to a maximum of £10,000.

Full Mid-Tier & Higher Tier applications with field options such as low input grassland or arable options last for five years with as many capital items as you wish to apply for (subject to CSFO approval).

Hedgerow & Boundary Grants

This scheme is open and will close on 1st May 2020. You cannot apply for this scheme if your fields are already in another Countryside Stewardship agreement. The maximum grant is £10,000 with two years to complete the work.

Payments are as follows:

Hedgerow laying - £9.40/m Hedgerow top binding & staking - £3.40/m Hedgerow coppicing - £4.00/m

There are no payments for fencing but both sides of the hedge/coppice must be fenced after to claim. Rural Payments prefer grants over £1,000. There are also payments for earth bank and stone wall restoration.
